

**Twin Rivers Community School District  
Board of Education Regular Meeting  
January 12, 2017**

The Board of Education of the Twin Rivers Community School District met on Thursday, January 12, 2017 at 5:45p.m. in the Bode board room for their regular board meeting. Board members present were Christine Bothne, Courtney Sampson, Brandon Jenson and Tom Olson. Davanna Fedkenheuer was absent.
